## COMPLETION OF CAPITAL RAISING AND CLEANSING NOTICE

Pura Vida Energy NL (**Pura Vida** or the **Company**) (ASX:PVD) is pleased to announce that it has completed a placement of 11,165,000 million new PVD shares at \$0.36 per share to institutional and sophisticated investors to raise approximately \$4 million (**Placement**).

Settlement of the Placement occurred today and the new shares will be allotted and begin trading on 25 February 2015. New shares issued under the Placement will rank equally with existing PVD shares.

All shares were issued under the Company's capacity under ASX Listing Rule 7.1.
