## **NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATIONS ACT**

This notice is given by Pura Vida Energy NL (“Pura Vida” or the “Company”) (ASX:PVD) under section 708A(5)(e) of the Corporations Act in relation to an issue of 16,320,000 fully paid ordinary shares in the Company on 8 May 2013 without disclosure to investors under Part 6D.2 of the Corporations Act.

A completed Appendix 3B in respect of the issue of new shares is attached.

### **Information required under ASX Listing Rule 3.10.5A**

Pura Vida provides the information as required under ASX Listing Rule 3.10.5A as follows:

(a) Dilution to existing shareholders as a result of the issue:

- Under Listing Rule 7.1 is 15%; and
- Under Listing Rule 7.1A is 10%.

The total dilution to existing shareholders as a result of the Placement is therefore 25%.

- (b) Pura Vida issued shares to institutional and sophisticated investors as it was considered to be a more efficient and expedient method for raising the funds to achieve its stated objectives.
- (c) The allocation of the shares under the Placement were made in conjunction with Hartleys Limited and RBS Morgans as Lead Managers.
- (d) No underwriting arrangements were in place for the Placement.
- (e) Commission for the Placement is 6% (plus GST) of the total funds raised.

The Company hereby notifies ASX under section 708A(5)(e) of the Act that:
